2. This permission of the Board of Governors in supersession of the MCI accorded initially for a period of one year and will be renewed on yearly basis subject to verification of achievement of annual targets as indicated in your scheme. This process of renewal of permission will continue till such time the infrastructure and expansion of hospital facilities are completed as per norms of Medical Council of India and the college is recognized.
